Hi Rochelle,

Current Annual Update costs are \$2,190. On January 1, 2017 the cost will increase to an Annual fee of \$2,450... billed every six months at \$1,225. This fee will include the two (2) Updates to Policies and By-laws, Administrative Guidelines/forms and associate visits to review the Updates; Special Updates; Annual notices; updated Employee, Student and Parent Handbooks; and a \$5,000 insurance against any challenge to the legality of policy language; policies and bylaws vetted by the Wisconsin legal firms of Davis & Kuelthau and/or Strang, Patteson, Renning, Lewis & Lacy. Your contract with Neola defines any additional incidental costs.

The Annual Maintenance fee to publish the districts on your web site is currently \$550 and I've not been informed of any increase. The Electronic Publishing Service will allow the policies/by-laws, administrative guidelines and forms to be published on the district's website via Board docs. As you know Neola is converting to Board docs with our next Update. You will be trained by Board docs before the next Update at no additional cost.

Bylaws and policies can be revised/added/ deleted at any time by the Board of Education. With Board docs the turn around time will be 1-2 weeks after the Board has adopted the changes and the changes placed in Board docs.
